YAYASAN PENERAJU SPONSORSHIP FOR PENERAJU PROFESSIONAL PENSIJILAN UNTUK SISWAZAH (PUSH) - PERAKAUNAN

A. PROGRAMME OVERVIEW

1. What is the programme about? What does it aim to achieve?

Yayasan Peneraju sponsorship for graduates programme is a newly introduced programme to assist eligible candidates financially by funding their professional certification fees and a partial of their tuition fees. The programme allows recipient to study on part-time basis only.

This programme aims to increase the number of Bumiputera graduates with professional certification in Accountancy recognised by the industry via the most suitable academic pathway.

2. Who is the programme for?

Yayasan Peneraju sponsorship for graduates programme is targeted at graduates who are interested in furthering their studies as a stepping stone to launch their accounting career.

Entry requirements are as below:

- i. Bumiputera;
- ii. Aged between 21 to 28 years old;
- iii. Graduated with a Degree in Accountancy or equivalent;
- iv. Obtained minimum of CGPA 2.50 or equivalent;
- v. Graduated less than 5 years and/or with less than 5 years working experience;
- vi. Currently enrolled or plan to enrol in selected professional accounting certification on a part time basis at any of Yayasan Peneraju's recognised learning training institution;
- vii. Minimum of two (2) papers or one (1) year left to complete under the sponsorship programme.

3. Which professional accounting certification would I be able to pursue under this programme?

Professional accounting certifications available under this programme are as listed below:

- i. Association of Chartered Certified Accountants (ACCA)
- ii. Institute of Chartered Accountants in England and Wales (ICAEW)
- iii. Certified Practising Accountant Australia (CPA Australia)
- iv. MICPA-CAANZ Professional Program (MICPA)
- v. CIMA Professional Qualification (CIMA)

^{*}the minimum number of papers are subjected to the professional accounting certification.

4. What are the benefits of this programme and how is it different from other programmes?

Through this programme, Yayasan Peneraju provides potential candidates with an opportunity to be a certified accountant by funding their professional certificate fees and a partial of the tuition fees. Application is open to all Bumiputera students currently pursuing or plan to pursue their professional certification at any of Yayasan Peneraju's recognised learning training institution.

5. How long is the programme?

In order to qualify for this programme, candidates must have a minimum of two (2) papers left to complete subject to the professional accounting certificate. The programme's exact duration will be based on the number of exemptions received and the remaining papers candidates have upon accepting the funding offer from Yayasan Peneraju.

The table below is a guideline and an estimated duration for each professional certificate. Recipient should complete the programme within the stipulated time as per below:

B. FUNDING

1. What type of fees are covered under this programme?

This programme is based on a top up funding model where Yayasan Peneraju will fully fund recipient's professional certification fees and a partial of the tuition fees. The **funding does not include monthly allowance and accommodation allowance.**

The general breakdown of the funding as per below:

- i. Tuition fees RM2,500 per paper;
- ii. Hundred percent (100%) of the professional certificate and examination fees;
- iii. Maximum two (2) additional resit attempts*.

*Resit attempts:

- Only two (2) additional resit attempts will be funded for the duration of sponsorship.
- These two (2) resit attempts could be utilised for the same paper.
- Tuition fees covered for resit attempt is fifty percent (50%) of the total tuition fees.

2. What are the consequences I would face if I breach the agreement with Yayasan Peneraju?

Recipient who withdrew or terminated from the programme are required to pay all payments incurred by Yayasan Peneraju on their behalf. The amount will be up to the point of termination.

3. Am I still eligible for this programme if I am attached to a student loan or another sponsorship?

Yes, candidates are allowed to be under a student loan or any other sponsorship, provided they declare their status to Yayasan Peneraju in their application.

C. LEARNING TRAINING INSTITUTION

1. Who are the learning training institution under this programme?

The recognised learning training institution selected by Yayasan Peneraju are as per list below:

2. Do I need to enrol at the selected learning training institution before applying for this programme?

Yes, candidates must be current active students undertaking any of the Professional Accounting certification at one of the learning training institution stated above. Candidates must have a minimum of two (2) papers subject to professional accounting certificate or at least one (1) year left to complete their certification at the point of applying for Yayasan Peneraju's funding.

New candidates who wish to pursue the certification are advise to contact the learning training institution for further information on certification and enrolment process.

D. APPLICATION

1. How do I apply for this programme?

Application is done online via the link provided at Yayasan Peneraju's website www.yayasanpeneraju.com.my and at respective learning training institution website. Candidates are able to get the latest news on this programme through Yayasan Peneraju's official Facebook, Twitter and Instagram account. Candidates who have registered their interest with us will also be contacted by our appointed programme manager for further application process.

2. What should I do after applying for this programme?

If your application is successful, you will be contacted by our **Programme Manager** for submission of required documents. It is important for candidates to ensure information provided in the application form is correct and complete. Failure to do so would result in unsuccessful application.

E. ASSESSMENT

1. Is there any assessment conducted as part of the selection?

Candidates are subjected to an interview session as part of the assessment process to select the qualified candidates.

2. If I pass the assessment, how will I be notified?

Those who passed the assessment will be notified via email or a phone call by our **Programme Manager**.

F. AGREEMENT/BOND

1. Would I be bonded with Yayasan Peneraju after I completed the programme?

Recipient who completed the programme within the duration given will not be bonded by Yayasan Peneraju and the funding will be converted into full scholarship. Recipient who breached the terms and conditions as stipulated in the Letter of Offer and Scholar Agreement will have to pay Yayasan Peneraju all payment incurred by Yayasan Peneraju on behalf of the recipient.

2. Am I required to commit to any kind of official contract/agreement?

Yes. An official offer will be made and candidates are required to enter into an Education Funding Agreement with Yayasan Peneraju.

3. Would I be able to reject the offer if I am shortlisted?

Yes. The agreement is only bonded after it has been signed by the candidate and delivered to Yayasan Peneraju.
